SUBJECT:	Approved Description for Specialized Accreditation Self Studies

The Southern Association of Colleges and Schools Commission on Colleges (SACSCOC) Policy on Accrediting Decisions of Other Agencies states that institutions that hold more than one accreditation recognized by the U.S. Department of Education must be accurate in their institutional description in the submitted self-study. Specifically, the SACSCOC policy states:

SACSCOC requires candidate and member institutions holding accredited or candidacy (pre-accredited) status from more than one U.S. Department of Education recognized accrediting agency to keep each agency apprised of any change in its status with one or another agency. Any institution seeking or holding accreditation from more than one USDOE-recognized accrediting agency must represent itself accurately to each agency with regard to purpose, governance, programs, degrees, diplomas, certificates, personnel, finances, and constituents, and must keep each USDE-recognized accrediting body, including SACSCOC, apprised of any change in its status with one or another accrediting agency.

To ensure this required accuracy, please use the enclosed *Approved Description for Specialized Accreditation Self-Studies* when describing Georgia Institute of Technology to programmatic and specialized accreditors in self-study documentation.

Additionally, should there be a change in status with a programmatic or specialized accreditor at Georgia Tech, including voluntary withdrawal from accreditation, please notify Dr. Loraine Phillips, SACSCOC Liaison, in the Office of Academic Effectiveness for communication to SACSCO.

#### Georgia Institute of Technology Approved Description for Specialized Accreditation Self Studies

The Georgia Institute of Technology, commonly referred to as Georgia Tech, is a public research university and institute of technology in Atlanta, Georgia. The school was founded in 1885 as the Georgia School of Technology. During its first 50 years, Georgia Tech grew from a narrowly focused trade school to a regionally recognized technological university. In 1948, the name changed to the Georgia Institute of Technology to reflect a growing focus on advanced technological and scientific research.

Georgia Tech is a unit of the 26-member University System of Georgia (USG). The USG is governed by the USG Board of Regents (BOR). Georgia Tech is one of four research institutions in the system with \$1.45 Billion in research and sponsored awards for FY 2023 to support research, discovery, and innovation.

The institution has many nationally-recognized academic programs, all top-ranked by peers and publications alike. As a leading technological university and member of the Association of American Universities (AAU), Georgia Tech has more than 100 centers focused on interdisciplinary research that consistently contribute vital research and innovation to American government, industry, and business.

The quality of the Georgia Tech educational experience is reflected in two important ways: consistently strong rankings by national publications and a prestigious highly regarded curriculum with a technological focus.

Georgia Tech has seven colleges and 30 schools focusing on Business, Computing, Design, Engineering, Liberal Arts, Sciences, and Lifetime Learning. The Institute is an innovative intellectual environment with more than 9,000 employees that include over 1,300 academic faculty and 2,400 research faculty. 47,946 students enrolled at Georgia Tech in the fall of 2023, with 19,505 undergraduates and 28,441 graduate students. Georgia Tech conferred 11,393 degrees in 2023, with 4,227 undergraduate and 7,166 graduate degrees. Serving over 190,000 alumni, Georgia Tech's annual budget is more than \$2.6 Billion.

Georgia Tech has an off-campus instructional site in Metz, France (Georgia Tech-Europe).
